- 6 month lease term – cost: \$1.00 if you want to purchase at end of term

## INDEPENDENT SUPPLIERS BLU-RAY

- \$1.50 up-front fee
- 40/60% split (you keep 60%)
- Minimum transaction fee: \$1.20 to \$1.25
- 90 day sell through - cost: \$4.00-\$4.50 vs. 40% of sales revenue
- 6 month rental lease term – cost: \$1.00 if you want to purchase at end of term
- \$6.00 to \$10.00 transaction fee guarantee
